SUMMARY

The person filling this professional position collaborates effectively with Victoria County Public Health Department (VCPHD) team members; coordinates services between and among outside agencies; and provides quality public health nursing services to meet the needs of the citizens of Victoria County. This professional also has frequent contact with personnel, state and county agencies, physicians, drug companies and vendors, medical centers and hospitals, and other stakeholders, including children and adults in the general population.

ESSENTIAL DUTIES AND RESPONSIBILITIES

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Performs tuberculosis case managements duties
- Engages in primary prevention and health promotion activities
- Manage adult and pediatric health screening, immunizations, tuberculosis, and sexually transmitted disease control activities
- Prepares correspondence and reports
- Performs lab tests
- Responds to the needs of the public and provides referrals to appropriate healthcare provider and agencies
- Provides patient care and consultations when necessary
- Travels to various locations, whether solo or in groups, on a regular basis to assist with or participate in clinics and other public health activities
- Performs “on-call” duty (i.e. monitors temperature of vaccines, hurricanes, and communicable disease epidemic)

- Performs data entry into EMR and various applications
- Exercises prudent nursing judgement to ensure the standards of nursing practice are implemented at all times
- Performs such other related duties as may be assigned by the Nurse Manager
- Complete the TB Nurse Case Management training in San Antonio, Texas
